

POWERADE G9 CONDITIONS OF PURCHASE

- Any transactions for 18 or more tickets will be managed via the TTK Premium Products Dept (dedicated phone and email – Ph: 09 307 5058 or email Premiump@ticketek.co.nz)
- 1. Tickets for the Powerade G9 (“Event”) cannot be refunded, exchanged or cancelled once issued, except in accordance with New Zealand law. The Event is held at Eden Park and the layout and course is at the absolute discretion of The Eden Park Trust (“us”, “we”, “EPT”).
- 2. Entry is open to everyone however: A minimum of 2 people are required per booking. Bookings of less than 6 people will be placed into a group of 6 to play a round. Team bookings are available for groups of 6 people. Teams comprised of under 18s must be accompanied by one adult (who will be admitted to the venue but not permitted to play unless registered as part of the team).
- 3. Cancellation or Postponement: **The Event will take place “rain or shine” however EPT reserves the right to cancel or postpone the Event (in whole or in part) at its discretion.** If the Event is cancelled or postponed EPT will offer either a refund or an alternative Tee time. A refund will be provided if you cannot play the rescheduled Tee Time (if offered) or in the event of cancellation. If EPT cancels the Event after its commencement for any reason, “hole in one” prize winners at the time of cancellation or postponement will receive their prize(s), subject to these terms.
- 4. You must abide by the instructions of the G9 staff, the Eden Park conditions of entry, the Event Rules, and ticket terms and conditions (and in the event of any conflict the listed terms will be preferred in this order). All players are expected to conduct themselves in a disciplined manner, demonstrating courtesy and sportsmanship at all times consistent with Golf etiquette and the Spirit of the Game. Rulings of the hole ambassadors are final.
- 5. Please arrive at Eden Park 45 minutes before your allocated Tee Time. If any member of your team arrives after your allocated Tee Time, they will be directed to join your team on the course and will not be permitted to play the holes missed (or be eligible for any applicable prizes at those holes) and the team will not be eligible for team prizes. Each team has 90 minutes to complete the nine-holes plus the additional bonus hole, par 3 course.
- 6. Prizes:
 - a. Team and individual and individual child (14 and under) prizes: There will be one team prize, one individual adult prize and one individual prize for the 14 and under category. The lowest score (for the team prize it will be the lowest combined score) in each of these categories will win the prize. Prize consists of one Eden Park membership for each player and one coveted yellow jacket for each player. In the event of a tie the winner will be settled by a sudden death playoff which will be scheduled by us after the Event has ended (and non-attendance for any reason will be a forfeit. All team members must participate in the sudden death playoff). To be eligible for the team prize a team must have 6 members participate in every hole and no substitutions are permitted.
 - b. Hole in one sponsor prizes: Eligibility - **you must not be a professional or ex professional player or coach to win a hole in one prize. The competition is open to amateur players only.** Entry and prizes will be subject to the terms and conditions displayed at each hole. A “hole in one” prize will be offered by each hole sponsor and will be awarded to the player who achieves a hole in one at the relevant hole. If (a) only one prize is offered for any particular hole across the duration of the competition, and more than one participant scores a hole in one on that hole, or (b) there are more hole in one winners than prizes for any specific hole, then the winner(s) will be drawn at random after the conclusion of the Event and the winner(s) will be contacted by phone or email. Prizes may be substituted by EPT where appropriate at EPT’s sole and unfettered discretion (for example, where age restrictions apply). Prizes will be awarded at the end of the Competition.
 - c. Donaldson Brown – Hole in One Competition. Eligibility – **To be eligible for the Donaldson Brown hole-in-one prize you must not be a professional or ex professional player or coach. The competition is open to amateur players only.** Rules for the competition: Any contestant who achieves a hole in one or a qualifying shot in the birdie zone of the Donaldson Brown Hole during the qualifying round will be invited back to participate at the end of the final day of the event (or at a time determined by EPT) to take a shot at the 8th hole (the “**Final Round**”). Each qualifying contestant will get one opportunity to hit a hole-in-one at the Donaldson Brown 8th hole in the Final Round, no practice shots or mulligans are allowed. To win the prize a contestant must hit a hole-in-one at the 8th hole in the Final Round. There is one prize only of (NZD)\$500,000 which will be shared equally in the event of multiple winners. The decision of the G9 staff on the day is final and no further correspondence will be entered into.
 - d. Other spot prizes may be offered on the day (ts&cs will apply).
 - e. No exchange or cash equivalent will be provided and prizes may not be sold nor used for any commercial purposes whatsoever. No correspondence will be entered into.
